WHL's Newest Addition - Newport

Women's Housing Ltd are proud to announce that the newest addition to the Women's Housing portfolio is nearing completion.

The Newport property, comprising 20 one and two bedroom units will be tenanted early March.

The Housing Services team are currently interviewing potential tenants for these units.

The property is aimed at housing older

women and women that may have experienced family violence in the past.



Bayswater

Women's Housing Ltd has recently received \$5.2 million funding from the Victorian Government towards the construction of 24 new apartments (8 x 1-bedroom and 16 x 2-bedroom) for women with or without children who are escaping family violence.

The new apartments will be built on Women's Housing Ltd owned land in Bayswater. "We all know there is a pressing need for more housing for vulnerable Victorians and Women's Housing Ltd is delighted with the support from the State Government and the City of Knox in helping us create new homes for women and children escaping family violence."

MONEY FOR JAM

Money For Jam

On Tuesday the 23rd of January 2018, Per Capita launched the pilot **Money** For Jam, a social innovation project specifically designed to address income poverty for older women. The program is designed to help women over the age of 50 supplement their income.

There were up to 30 participants who welcomed the first "Jam Training Session". Each participant will be linked to a mentor who will provide support to the women throughout the twelve month journey.

Older women are increasingly at risk of homelessness and unemployment. **Money For Jam** provides mentoring for women at risk of homelessness to turn their hobbies and passions into micro-enterprises.

The **Money For Jam** model was co-designed in 2016 by 13 women over 50 who were experiencing homelessness and deprivation, in collaboration with Per Capita's Centre for Applied Policy in Positive Ageing (CAPPA). Tenant's of Women's Housing Ltd with Lindy Parker, Operations Manager took part in this research phase. This process led to an innovative solution for helping older women alleviate income poverty

through micro-enterprise. CAPPA will now pilot the program in Melbourne over 18 months.

The pilot will be delivered with community partners Fitted for Work, **Women's Housing Ltd**, and will support up to 80 women currently accessing homelessness and employment services.

Security & Safety

Safety and Security Focus Group

Women's Housing Ltd asked tenants for feed-back on the design of WHL properties so that we could feed this into future building designs.

The feed-back has now been reviewed and over the coming twelve months Women's Housing Ltd are running a number of focus groups to

learn more from our tenants. The first focus group was held on the 7th February 2018 and this reviewed the level of safety and security that tenants had in their properties.

This session provided Women's Housing Ltd with some useful information. The security measures which were identified by the group have been accepted by WHL to be installed at certain properties. These items include installation of security doors, monitored alarms on fire escape doors and increased number of video monitoring cameras. These items will be installed following our tendering process over the next six months.

Maintenance - Who are you going to call?

Urgent repairs

Always call the repairs line immediately on 03 9412 6868 dial option 2.

Urgent repairs include smoke alarm failures, no power to the property, no hot water and trip hazards in your home or common area. The response time for emergency repairs is 24 hours.

Urgent After Hours Repairs

Should an urgent matter occur after hours that requires an immediate response, call:

Routine and Non urgent repairs

Can be reported via the maintenance line on 03 9412 6868 dial option 2.

The response time may be up to 14 days depending on the issue. and post it.



Women's Housing Ltd - Phone System

Many tenants have told us that they were experiencing difficulty contacting our service.

As a result, Women's Housing Ltd adopted a new telephone system.

We also sent out letters to all tenants advising of direct numbers of key Women's Housing Ltd staff. If you call Women's Housing Ltd on the main line, ph: 9412 6868; you will be asked to select an option. If you wish to talk to a property officer re a maintenance issues, select option 2. If you wish to speak to a tenancy worker, select option 3.

At times, staff may not be available. They may be working out of the office or attending to another call, please leave a message and a staff member will call you back as soon as possible.
