This conference will bring together affordable housing providers, academics, government, property developers and other stakeholders to promote women's housing and the professional development of women working in the housing sector.



Corner of Flinders and Swanston Street



#### 1. BY CAR

Enter Federation Square via the Russell Street extension turning left into car park. Proceed to lifts and take lifts to level 3. When exiting the lifts turn left and proceed to the end of car park Take stairs to the ZINC entrance at river level

#### 2. DROP OFF/ ON FOOT

Proceed to end of Russell Street extension. Take stairs on right down to ZINC entrance at river level.

stairs to 7INC

From the main plaze From the Prince's head towards BMW edge at the end of the Bridge head down the Yarra along River Terrace until you reach ZINC.
